The Future of EUWIN



As many of you know, EUWIN (the European Workplace Innovation Network) was created in 2013 at the instigation of the European Commission's DG GROW, and was co-led by Steven Dhondt (TNO) and Peter Totterdill (WIE). Over the next four years, EUWIN built a

substantial network across Europe and beyond, hosting events in several countries and building a definitive workplace innovation databank.

EU funding ceased in 2017. EUWIN has since been supported by a consortium of partners, enabling it to continue its mission to raise awareness of workplace innovation and to share evidence-based practice through webinars, conferences and the provision of online resources. Since 2023, the Knowledge Bank has been incorporated within Fresh Thinking Labs, an online platform providing free access to diverse resources and opportunities for collaboration.

The BroadVoice Roadmap to Positive Change



The BroadVoice project's [Roadmap](#) makes a key contribution to our understanding of workplace innovation in practice, bringing together representative and direct employee participation into a single, joined-up framework for positive workplace change.

Co-funded by the EU's *Improving expertise in the field of industrial relations* budget line, BroadVoice investigates and fosters the role of trade unions and worker representatives in

stimulating, informing and sustaining workplace innovation, leading to positive outcomes for employees and businesses alike.

The project was created to help address the gap between evidence-based practice and common practice at enterprise level, and to build a better understanding amongst company leaders and social partners of “what works” in practical terms.

The [Roadmap](#) offers an actionable guide for practitioners based on findings from BroadVoice. Together with an introductory video, it is available in Bulgarian, Dutch, English, Italian, Slovenian and Swedish.

Kirchhoff's workplace innovation journey was one of the formative influences on the BroadVoice Roadmap.
